## International Student Information Form INSTRUCTIONS

**Clearwater Christian College** welcomes student applicants whose citizenship is from countries other than the United States of America. It is believed that international student brings a unique perspective to both the classroom and residence hall environment. In addition, the College is encouraged to accept the opportunity of training these individuals as they return home to reach their own country for Christ.

The purpose of this flier is to inform international students of specific procedures associated with their possible enrollment and to obtain specific information for the preparation of the required student visa. In order to evaluate your application for admissions, we will need to receive the following.

- International students are required to submit a completed General Application for Admission and International Student Information Form along with the required recommendations, academic documentation, and fees no later than 90 days prior to the month of anticipated entry (June 1 for the fall term and October 1 for the spring term). A \$35 application fee must accompany the General Application for Admission.
- The only visa the United States Immigration and Naturalization Service (INS) will recognize for international students is the F-1 Student Visa.
- International students must enroll as degree seeking and carry a full-time academic load. The minimum full-time academic load is 12 semester hours. International students may include online courses in their course registration for fall and spring semesters as long as a minimum of 12 hours does not include online instruction.
- Residence hall housing policies are in effect for international students (see General Application for Admission). Applicants who are over the age of 25, are single, never married, with no dependents, and wish to reside on-campus in the residence hall may request an exemption to the stated policy.
- International students whose native language is not English are required to submit satisfactory scores from a recent administration of the Test of English as a Foreign Language (TOEFL). The minimum TOEFL result accepted is 500 (paper-taken examination) or 173 (computer-taken examination). - International students are ineligible for financial aid available to citizens of the United States from national and state sources. The only possible assistance available through the College is that which is offered through our institutional financial aid program. Contact your admissions counselor for assistance in this area.

- Unless granted a Work Permit by the INS, international students are limited in their work opportunities to on-campus employment. During the school year, international students cannot work more than 20 hours per week. Interested students are required to complete the Campus Work Application available through the College's Financial Aid Office. The College does not guarantee international students work on campus during the school year, between academic terms, or during the summer break. NOTE: It is impossible for international students to obtain a Work Permit from the INS during the first year of enrollment. For subsequent years, proof of extreme hardship and change of financial support must be presented to the INS before such permission is granted. The international student should not enroll expecting this permit to become a reality.
- One of the major requirements of the International Student Information Form is the documentation of the applicant's ability to satisfy the anticipated cost of attendance. The budget figures below are estimates the College has devised for the student type listed. The budget estimate for your student type should be entered on line 7 on the attached form.
